All vehicles will be parked in designated spaces. Do not block gates or shop garage doors. Do not park on the grass. Do not park in areas marked in red or block fire hydrants. Do not park in faculty or handicap marked spaces without the appropriate tags. **(SEE THE STUDENT HANDBOOK FOR APPLICABLE PENALTIES AND FINES FOR PARKING VIOLATIONS).**

Vehicles parked on school property are subject to the same policies governing other areas owned or controlled by the school district. This includes vehicles at any campus within the PN-GISD. Such vehicles may be searched by school authorities when there is reasonable suspicion to believe that a school, local, state or federal guideline or law is being violated. **Each student is responsible for the contents of his/her vehicle.**
